



Issue: Request approval to purchase new Library furniture for various college wide projects utilizing the Department of Management Services (DMS), State of Florida Contracts.

Background/Analysis: DMS has awarded contracts for Library furniture to various manufacturers based on discounts off the manufacturer's list pricing; the Library furniture items are purchased from local dealers, which include M/WBE firms. Contract #420-590-07-1 is valid through February 20, 2011. The fiscal impact indicated below is for purchases in May 2009. 
