DELIVERY OF WORK

Accepted works may be hand delivered or shipped prepaid. Shipped entries must be packed in sturdy, reusable containers and sent to Beth Ravitz, Gallery Director, Broward Community College, Building 3, 3501 S.W. Davie Road, Davie Florida 33314. All work must be pre-paid two way shipping via UPS. All shipped work is due May 16 between the hours of 9am and 2pm. All work is returned via UPS unless pre-paid two way shipping is included.

ELIGIBILITY

Open to artists residing in the United States. Work in all media, presenting the theme "*Places to Rest*," is eligible. All art work must be suitable for installation, and 3D work must be light enough for two people to handle.

JUROR

Rod Faulds, Director, University Galleries, Florida Atlantic Univ., Former Assistant Director for Operations Guggenheim Museum, New York City.

AWARDS

There will be up to \$1,500 in cash awards.

ENTRIES

Entry Deadline is April 18. Complete and include your official entry form, jury notification card, and a check for the \$20 non-refundable entry fee with the card/form and slides. A maximum of 2 works may be entered. Note that the \$20 fee is for 2 entries/slides. Three Dimensional work may include no more than 2 views of each entry. Send entries to Fine Arts Gallery, Broward Community College, Building 3, 3501 S.W. Davie Road, Davie Fl. 33314 and make checks payable to Broward Community College.

SLIDES

Entries will be judged from 35mm slides in standard mounts (not glass). Label slides with name, title of work, medium, dimensions (h x w x d), and indicate top, and date. Slides will be returned if a self addressed stamped envelope (SASE) is enclosed.
