Unit 7 Organizing for Incidents or Events

Unit 8 Incident Resources Management

- 8.8 Identify five key considerations associated with resource management and the reason for each

Unit 10 Incident and Event Planning

- 10.4 Explain the use of Operational Periods in the planning process, and how Operational Periods are derived
- 10.5 Explain the function of the Operational Planning Worksheet and other forms which may be used in preparing the Incident Action Plan
- 10.6 Explain the criteria for determining when the Incident Action Plan should be prepared in writing

Unit 11 Understanding and Recognizing Terrorism

14.4 Given a case study, identify tactical considerations for each incident category.
