## SUSPICIOUS ACTIVITY

### Incident Location:

Central Campus            Building 9

### Date of Occurrence/s:

Wednesday, January 18, 2017 at approximately 6:40 AM

Tuesday, January 17, 2017 at approximately 8:00 PM

Monday, November 7, 2016 at approximately 5:25 PM

### Incident Details:

- Three similar suspicious incidents have been reported to Campus Safety. The incidents purportedly occurred at Central Campus within female restrooms of Building 9.
- The first suspicious incident was reported to have occurred on Monday, November 7, 2016 at approximately 5:25 PM. The reporting individual asked the subject where the restrooms were. Once in the female restroom, the reporting individual became aware that the subject entered the restroom and was silently standing directly outside of the stall which the reporting individual was using. The reporting individual stated that the shoes matched that of the subject that they received directions from. The subject is described as a black male, wearing a red shirt, black shorts, and red and black shoes with a black backpack in his possession.
- The second suspicious incident was reported to have occurred on Tuesday, January 17, 2017 at approximately 8:00 PM. The reporting individual stated that as they were walking through the building they witnessed a male walking behind them. Shortly after the reporting individual entered the female restroom, the male subject entered the female restroom and began rattling the stall doors until an unknown female entered the restroom and told the male subject to exit the female restroom. The subject is described as a black male, 21 years old, wearing a green t-shirt, shorts, and red/black footwear.
- The most recent suspicious incident was reported to have occurred on Wednesday, January 18, 2017 at approximately 6:40 AM. While the reporting individual was using the restroom, the door to the female restroom opened and the subject entered breathing extremely heavily. After a minute or two the subject exited the restroom. As the reporting party attempted to exit the facility, the subject reentered the restroom. The reporting party notified the subject that it is a female restroom and the subject exited. The subject was described as a black male, approximately

in their early 20's, wearing glasses, and light colored short sleeve shirt, and black pants. The subject stated that they were a student.

- The Town of Davie Police Department and Broward College's Department of Safety, Security, & Emergency Preparedness are investigating these reported suspicious incidents.
