**Students must be US citizens, eligible noncitizens or International to be considered. Generally, you are an eligible noncitizen if you are:**

- A permanent U.S. resident with a Permanent Resident Card (I-551)
- A conditional permanent resident (I-551C)
- The holder of an Arrival-Departure Record (I-94) from the Department of Homeland Security showing any one of the following designations: "Refugee", "Asylum Granted", "Parolee" (I-94 confirms that you were paroled for a minimum of one year and status has not expired), "Victim of human trafficking", T-Visa holder (T-1, T-2, T-3, etc) or "Cuban-Haitian Entrant"

**Scholarship requirements:**

- Must be enrolled as a full-time or part-time degree seeking student with a GPA of at least 2.5.
- Financial Need (International students may apply)
- Must submit two letters of recommendation with your application.
- An essay answering the questions below.
