Two Transformative Justice Programs Launched

The College has launched two new programs aimed at improving access to post-secondary opportunities for residents. Through its new Transformational Justice programs, launched on February 7, at the Willis Holcombe Center in Fort Lauderdale, the College is collaborating with the Broward County State Attorney's Office and the Law Office of the Public Defender for the Court to College Diversion program and with the Florida Department of Corrections for the Corrections to College program. Both programs offer residents of Broward County who have been involved in the legal system the opportunity to be enrolled in skills training and receive industry-recognized credentials that can lead to sustainable employment.

The Court to College Diversion program allows first-time nonviolent offenders charged with a third-degree felony or lower offense to avoid a criminal conviction. Their case is diverted from the trial court process, and they can instead pursue an opportunity to improve their technical skills in high-demand industries. A hallmark of the diversion program is the required collaboration between the Court to College participant and the person listed as the victim in their case.

The Corrections to College program offers individuals housed at the Hollywood Community Release Center (CRC) – which serves only women who are in the last 18-months of their sentence – with the opportunity to participate in educational programming provided by Broward College. Participants will attain industry-recognized credentials for jobs in high-demand industries; courses will begin prior to release and be completed post-release.

Most recently, she expanded her support to include all of the Strategy, Assessment, and Research team when it was formed in 2022.

The month of January was dedicated as National Human Trafficking Prevention Month in 2010, and each year the call to bring awareness and end the demand for human trafficking has become stronger across the country. In observance of this, Broward College's Social Behavioral Sciences and Human Services Pathway, the Broward College chapter of Project Stay Gold, the Institute of Public Safety, and Alumni and Friends hosted a variety of awareness-raising events in person and online, culminating in a successful 5K Walk-For-Awareness on the morning of Saturday, January 28, at the A. Hugh Adams Central Campus. More than 150 people, including President Haile, students and members of the community participated in the event.

President Haile Appointed Deputy Chair of the Federal Reserve Bank of Atlanta

President Haile was appointed by the Federal Reserve Board of Governors to deputy chair of the board of directors of the Federal Reserve Bank of Atlanta. His term as deputy chair began on January 1, 2023, and runs through December 31, 2024. Haile is the first education leader to serve as deputy chair of the Federal Reserve Bank of Atlanta in approximately 70 years and is the first public college president to serve in the position. Haile serves on the board's executive committee alongside the chair, performing essential leadership and governance functions of the Bank. Federal Reserve Member Banks appoint Class A and B directors, while the Federal Reserve Board of Governors appoints Class C directors. The Reserve Bank's chair and deputy chair must be Class C directors. Haile was appointed as a Class C director at the start of 2022.

The listing mentioned that President Haile has been a champion of economic mobility for first-generation college students in the region.

Dean of Student Services David Kenton Appointed Chair of the Children's Services Council of Broward County

Dean of Student Services Dr. David Kenton was appointed chair of the Children's Services Council (CSC) of Broward County on Thursday, January 19. A longtime resident of Broward County, Dr. Kenton was first appointed to the board of CSC in 2020. The mission of the organization is to provide leadership, advocacy, and resources necessary to enhance the lives of the children of Broward County and empower them to become responsible, productive adults through collaborative planning and funding of a continuum of quality care.

Broward College Launches New Customer Relationship Management Tool Target X

To better serve potential students, the College launched a new Customer Relationship Management tool (CRM), TargetX, on January 29, 2023. The CRM is being used college-wide by all departments who recruit and onboard credit and noncredit students. TargetX will facilitate the building of stronger relationships with prospects and applicants using improved communication tools that automatically track engagement from the first point of inquiry through registration and payment. A new online application is also included in the launch.



Department of Labor Awards Broward College \$2 Million for Community Employment Project

A \$2 million grant by the U.S. Department of Labor, Employment and Training Administration (ETA) will help the College enhance access to in-demand courses and programs, career readiness, and related support services in Broward UP communities. The ETA Community Project will make an impact by annually serving 600 residents over three years in workforce training leading to industry certifications. The project will also help construct a health sciences clinic at the Broward College @YMCA, support the use of the iSTEM Center and the TRIO Education Opportunity Center mobile units for career exploration and completing college applications, and expand the workforce education leading to industry certifications offered in the Broward UP communities and beyond.

Lennar Homes Foundation commits \$1 Million to Broward College to Help Specialized Population and Promote Post-secondary Education

Broward College received a \$1 million commitment from the Lennar Foundation to expand three programs aimed at connecting specialized populations to post-secondary education. The funding will support the Court to College Diversion program, which offers educational opportunity in lieu of



prosecution to cases that involve individuals who have committed minor offenses. It will expand the Corrections to College program which gives inmates workforce skills so that they are marketable for employment for meaningful jobs and wages upon release. It will also support the Soar to the Top program, in which the College partners with high schools in Broward UP communities to build early awareness and interest in post-secondary education.

Second Cohort Completes Broward College Leadership Empowerment and Development Program

The Broward College Leadership Empowerment and Development program (BC LEAD) is a 24-week blended-format leadership program that is grounded in the framework of the 5Cs of Leadership Credibility (Competence, Character, Composure, Courage, and Care for People). The program schedules facilitators from both internal Broward College leadership and external subject matter experts covering topics such as Effective Communication, Creating a Culture of Belonging, Problem Solving, Conflict Resolution, Employee Engagement, and Courageous Coaching. The second cohort of the program kicked off on August 5, 2022, and concluded with capstone presentations on January 27, 2023. Cheered on by their managers, the 15 participants demonstrated through a capstone case study the innovative ways they can put their learning into action. The participants of cohort two included associate deans, directors, senior directors, managers,



and supervisors representing various areas of the College. The participants will now move on to a five-month Mentoring Pod experience led by nine members of College Leadership. The third cohort began on February 3, 2023, with 20 enrolled to kick off their BC LEAD professional development journey.

Grants From U.S. Department of Education and Florida Blue to Address Students' Basic Needs

The U.S. Department of Education has awarded the College almost \$1 million to implement the Basic Needs for Postsecondary Students (BNPS) project, along with more than 27 partner organizations. Broward College is one of three community colleges to receive the award. The overall goal of the project is to increase education opportunities by removing barriers to post-secondary completion and workforce success. The project will leverage the resources and systems already in place through Broward UP by using Career Pathway Navigators to assess the needs of students beyond their academic requirements. The project offers food assistance, housing, transportation, access to physical health and mental health support, child care, and technology through Broward College, community, and partner agency resources.





The College also received two grants totaling \$30,000 from the Florida Blue Foundation to support student needs. A grant of \$20,000 will go toward establishing a food pantry at the newly opened Broward College @ YMCA and \$10,000 in funding will go to Seahawk Outreach Services (SOS) to assist Broward College students experiencing homelessness.

Broward College Receives \$3 Million Grant to Bridge the Digital Divide

Broward College was awarded almost \$3 million by the U.S. Department of Commerce, National Telecommunications and Information Administration to implement the Connecting Broward UP Communities (CBC) project. Broward College is currently the only recipient in Florida to receive this award. The project will expand broadband access and technology for workforce education and employment opportunities for residents in its Broward UP communities, which consist of 11 zip codes, and almost half of the 31 municipalities in Broward County. Designed to expand broadband adoption, access, and capacity in communities where





a digital divide continues to pose a barrier to educational attainment and socio-economic progress, the overall goal of the project is to ensure all residents have access to broadband services. Broward College will create access points with broadband and technology devices through partner agencies within Broward UP communities, provide loaner laptops, subsidize broadband services and technology support to students in Broward UP communities, and provide digital literacy and workforce education training to support entry into the workforce.

Broward College Honors Legacy of Martin Luther King, Jr., with MLK Day of Service at Central Campus

Peer Leaders of the Peer Leadership and Mentoring program along with some College participated in a volunteer event on Monday, January 16, in honor of Dr. Martin Luther King, Jr. The participants helped pack 2,036 bags for LifeNet4Families and stock 15 pallets of food for the Seahawk Marketplace Food Pantry. LifeNet4Families provides a gateway to stability for people in Broward County experiencing hunger, homelessness, and poverty. The event was organized by the Sisterhood in the Workplace Employee Resource Group. Approximately 40 people attended the event. This is the third year that Broward College has hosted an MLK Day of Service. MLK Day is the only federal holiday designated as a National Day of Service to encourage all Americans to volunteer to improve their communities.

President Haile served as a panelist for the first session of the 2023 Aspen Institute New Presidents Fellowship, a nine-month program focused on helping college presidents advance student outcomes across completion, learning, transfer, and employment, with a focus on low-income students and students of color. The audience included 25 community presidents from across the country who have committed to a multifaceted program that helps leaders in the

Participants spoke on various themes related to the topic, with President Haile highlighting the work of the College, including

Each year, Leadership Broward brings together 60 leaders in the fields of business, non-profit management, education, media, government, and more for a day of information sessions, workshops, and networking events. The mission of Leadership Broward is to educate participants on the educational and civic issues and challenges facing the South Florida community, and to provide encouragement and information on ways to contribute to the solution. Russell McCaffrey, dean, Transportation Programs, also addressed the group.

The objective was to help students develop a deeper understanding of the Holocaust and other modern-day genocides. The United Nations General Assembly designated January 27 as the International Holocaust Remembrance Day. January 27 is the anniversary of the liberation of Auschwitz-Birkenau concentration camps.

TRIO Students Receive Laptops Following Educational Trip to Universal Studios in Hollywood, California

From June 3 to June 6, 2022, 10 high school students who are part of the Broward College TRIO Upward Bound program were given a surprise trip to Universal Studios Hollywood in California to attend a college fair, meet talent from the film "Jurassic World Dominion," and preview the new film. More recently, on November 30, the students received another surprise as they were given laptops to use for their educational advancement. The trip and laptop donation were organized through a collaboration between Universal Pictures Council for Opportunity in Education (COE) and Comcast Project Up to help strengthen STEAM (Science, Technology, Engineering, Art, and Mathematics) preparation among low-income, first-generation college-bound students participating in federal TRIO Programs.



During the trip, students engaged in an animatronics course designed by educational professionals with input from key experts from the new "Jurassic World Dominion" film. For some students it was the first time flying on an airplane or traveling outside of Florida. The Broward College TRIO Upward Bound program is funded by the U.S. Department of Education to serve 240 high school students annually. The program is fully grant funded, and all academic services and experiences are free to participants. Broward College can now leverage technology with its Upward Bound students because they have direct access to laptops beyond a loaner program.

TRIO ASPIRE Talent Search Fall Tour

The TRIO Talent Search ASPIRE team hosted Boyd Anderson High School seniors at Broward College on Friday, December 9, 2022. Approximately 25 students and administrators attended the events. The students engaged in presentations pertaining to enrollment and scholarship writing before touring the Health Sciences Simulation Center, STEM/Coding department, the Rosemary Duffy Larson Gallery, and the recording studio. This event exposed students to a post-secondary environment and allowed them to engage in different areas of study.









Broward College Commemorates Black History Month with a Variety of Educational Events

BOARD NEWS

First Student Forum for 2022-23 Hosted at the A. Hugh Adams Central Campus

The first Student Forum for 2022-23 was held on the A. Hugh Adams Central Campus on February 7. Representatives of the Student Government Association (SGA) presented on recent initiatives and the results of a campus-wide survey on student life. Led by SGA President of Central Campus Louise Gong-McGovern, the presentation focused on the SGA's theme for the year: Seen and Heard. Student senators and members of the executive board shared developments on how the SGA was moving to meet the goals of increased civic engagement, inclusion of all students, and broader student engagement. These initiatives included a student town hall in November of 2022, a student showcase for international students, and a civic engagement drive designed to increase voter registration among Broward College students and staff.

The SGA representatives also shared the results from a survey of students from the fall 2022 semester. The survey revealed that 92 percent of students were either "satisfied" or "very satisfied" with their Broward College experience. It also showed that 30 percent of students believed that "food offerings" was the area with the greatest need for improvement on Central Campus. That was followed by "financial aid," which 13.64 percent of students said needed improvement, and "transportation," which 10.3 percent of students said could be improved. The presentation concluded with a list of measurable steps that Broward College is taking taking to address those areas, including the development of a more streamlined financial aid application process and the extension of the Broward College Lyft Ride Program. After the conclusion of the student forum, SGA President Louise Gong-McGovern then attended the regularly scheduled Board of Trustees meeting as a student representative.

Board of Trustees Receives Legislative Update from General Counsel and Vice President of Public Policy and Government Affairs Lacey Hofmeyer

General Counsel and Vice President of Public Policy and Government Affairs Lacey Hofmeyer updated the Board on recent legislative events. Her presentation focused on items related to the state budget, and the standing of Broward College's request to expand and remodel its STEM Center. In her presentation, Vice President Hofmeyer noted an overall increase in the total amount for Program Funds in the Governor's budget, as well as additional funding through the Post Secondary Library Network and the LINE Grant Program. Other noteworthy policy proposals included several bills relating to tuition remission for spouses and dependents of deceased or disabled veterans and servicemembers. To conclude, Vice President Hofmeyer shared that the College's STEM Center Expansion and Renovation request was ranked second on the Florida Department of Education's Three-Year Priority List in its Legislative Budget Request.

Board Receives Update on Social Enterprise Plan Impact: Empower Student Development

Isabel Gonzalez, chief of staff and vice president, Communications and Community Relations, provided the second of three updates on the strategic priorities of the Social Enterprise Plan during the Board of Trustees meeting on February 7. In her presentation, VP Gonzalez outlined progress made on the Strategic priority "Empower Student Development" and its supporting tactics. Under the Develop Sustainable Financial Independence tactic, she highlighted the goal of expanding support for students to attain their academic pursuits by planning to launch the first full course of the Financial Wellness Institute (FWI) in March. The programming for the course was built by incorporating data gathered from BCEx (Broward College Entrepreneurship Experience) regarding financial literacy needs for development of the broader FWI, and leveraging existing continuing education offerings to build programming.



For the Customize Learning Experiences through Multiple Modalities tactic, she briefed the Board on the College's plan to increase the number of faculty trained to deliver blended, online, BC Online Live, and flexible modalities. This plan includes hosting ongoing training sessions for all modalities and reviewing and updating the user guides for blended, online, and BC Online Live modalities. For the Provide a Best In-Class Student Experience tactic, Vice President Gonzalez explained the College's progress toward understanding the full student experience and identifying key points that need to be addressed. She outlined how through partnerships with the consulting firm CampusWorks, the College is moving toward acquiring and engaging tools to comprehensively measure and respond to student experience sentiment. The next presentation in the Social Enterprise Plan Impact series will be on the priority "Create Impactful Career Connections" and its supporting tactics.

Cloud-Enabled Hosting Service CSPi Technology Solutions To Be Renewed for Six Months

Broward College's contract Technology Solutions with CSPi, a company that delivers network adapters, multicomputer systems, IT managed professional services, cybersecurity programs, and data centers has been renewed for six months with the approval of the Board of Trustees on Tuesday, February 7. Tony Casciotta, vice president, Information Technology, delivered the proposal. The College originally outsourced to CSPi through a competitive bid in 2017. It has been used to fill a variety of needs, from data infrastructure to perimeter security. As the current contract is set to expire in June of 2023, the proposal will help carry the contract through to the end of the calendar year. As Vice President Casciotta explained, a competitive bid is currently being put together for a similar data infrastructure hosting service.

Board of Trustees Votes to Authorize 100 Additional Salesforce Licenses

The Board of Trustees voted to authorize the purchase of 100 additional licenses for Salesforce, a cloud-based customer relationship management (CRM) platform. This approval follows an original agreement



with Salesforce that was authorized as part of the targeted contract to acquire the customer relationship management tool in March 2021. The proposal was presented by Janice Stubbs, vice president, Student Services. In her presentation, Vice President Stubbs described the importance of Salesforce to the frontline staff who onboard students across a variety of programs at Broward College.
