Broward College Receives Transformational Gift of \$30 Million

Inspired by Broward UP™, Mackenzie Scott and Dan Jewett made a transformational gift of \$30 million. Three years ago, Broward College launched Broward UP to improve economic mobility in the most challenged communities by expanding the College's service model into six zip codes, representing more than one third of Broward County cities with the highest unemployment and lowest

education attainment rates. With the additional funding, Broward UP will exist in perpetuity, and Broward College will strengthen its support throughout Broward County.

Broward UP began with limited investment. The hope is that this gift will inspire others to join in raising Broward County's post-secondary education attainment and economic mobility for all. Read the College's statement on the gift.

Broward College COVID-19 Update

The College has adjusted its safety measures in response to the changing environment, lessons learned, and updated statutory and federal guidelines. Effective Friday, June 25, face coverings are no longer required while on campus. However, those who have not been vaccinated are strongly advised to continue wearing a face covering.

In preparation for a return to a new normal this fall and as college-sponsored events begin to be held on campus, students, employees, and all other members of the Broward College community are strongly encouraged to get vaccinated against COVID-19 and continue to practice social distancing. Enhanced cleaning protocols will continue at campus facilities, and personal protective equipment (masks, hand sanitizers, plastic shields) will be made available as requested by departments.

Dr. Jeffery Nasse Selected as Provost

Following a national search, Dr. Jeffery Nasse was selected as provost and senior vice president, Academic Affairs, from a field of 89 candidates representing public and private colleges and universities across the nation.

Dr. Nasse, who currently serves in an interim capacity, will officially assume the role on July 1. Since joining Broward College in 2005, Dr. Nasse has served as a tenured faculty member, senior associate vice president of Academic Affairs, dean of the Education Pathway, dean of Academic Affairs, dean of Academic Resources and Writing Programs, associate dean of English, and associate dean of Communications and Fine Arts.



Upon his honorable discharge from the Marine Corps in 1994, Dr. Nasse attended East Carolina University, where he earned a Bachelor of Science in Communication in 1999, and a Master of Arts in English in 2002. He completed his Ph.D. in Educational Leadership and Research Methodology at Florida Atlantic University in 2013.

Speaker Series Features Internationally Acclaimed Chef José Andrés

Following a postponement due to COVID-19, the Broward College Speaker Series resumed on Monday, May 17, with chef José Andrés. The internationally recognized culinary innovator, author and humanitarian appeared in a virtual discussion on "Changing the World through the Power of Food," moderated by Kelley Shanley, president and CEO, Broward Center for the Performing Arts. Andrés provided insights into current food and hunger issues and how he uses food to empower communities and strengthen economies. Andrés is a committed advocate of food and hunger issues and is known for championing the role of chefs in the national debate on food policy. In 2010, he formed World Central Kitchen, a non-profit that provides solutions to hunger and poverty through food. Andrés was recognized as one of TIME's "100 Most Influential People" in 2012 and 2018. He was awarded "Outstanding Chef" and "Humanitarian of the Year" by the James Beard Foundation. The one-hour discussion was followed by a question-and-answer session for VIP ticket holders.



Virtual Events Mark Caribbean-American **Heritage Month**

Broward College marked Caribbean-American Heritage Month with virtual campus events throughout June that celebrated and commended the spirit, unique talents, and vibrant culture of the many Broward College students, faculty, staff, and friends who have origins in the Caribbean. The events ranged from presentations on Carnival and Juneteenth to music and a documentary viewing. The U.S. House of Representatives established Caribbean-American Heritage Month in 2005 to recognize the significance of Caribbean people and their descendants in the history and culture of the United States.



Broward College Professor Gives Presentation on Juneteenth

Robert Morris, professor of History and Political Science, participated in a virtual discussion, Tuesday, June 15, on "Juneteenth: Discussing the History, Meaning and How It's Celebrated." The event was part of activities sponsored by the City of Miami Beach to commemorate June 19, 1865, the day when enslaved Black people in Galveston, Texas, learned of their



freedom from Major Gen. Gordon Granger of the Union Army, who announced the end of the Civil War two months after the surrender of Confederate General Robert E. Lee in Appomattox, Virginia. Professor Morris was joined by moderator Kunya Rowley, founder and artistic director of Hued Songs, and Janey Tate, publisher, and editor-in-chief of HyLo News Miami.

Students Give Rapid Credentials Boot Camp Thumbs Up

Students enrolled in the Medical Assisting program took part in a three-day boot camp this spring at the site of a local health care provider, during which they received hands-on practice in basic clinical skills, infection control procedures, EKG, and phlebotomy training leading to Basic Life Support (BLS) certification. The boot camp was offered through Broward College's Rapid Credentials program, which, thanks in part to a grant from the Florida Department of Education, is helping students boost their earning potential, gain a competitive edge, and fast-track their careers through in-demand, high-quality workforce education. The positive responses from participants in the course and boot camp mirror those of students Sarah Edouard and Maria Mezquita.

"Our BLS instructor was amazing," said Sarah, who is now working on pre-requisites to continue with nursing school. "It was very interesting learning how to do CPR on adults, children, and babies. This is a skill I will use for the rest of my life, whether I am working as a nurse or away from work."

"The boot camp was a fantastic experience," said Maria. "The hands-on training helped me understand some of the questions that could only be answered by practicing and performing the skills. I am confident and ready for a job as a clinical medical assistant."

Board of Trustees Approves 2021-2022 Budget

The Broward College District Board of Trustees approved a \$190.5 million budget for the fiscal year 2021-2022 that enables the College to prioritize investments in the student experience and their employment outcomes. The budget titled, Building Resiliency: Investing in Our Students, Our People, Our Future was approved at the regular monthly meeting on Tuesday, June 22, on the Judson A. Samuels South Campus. Apart from an emphasis on increasing the number of students enrolled, certifications and degrees earned and post-completion placements, Building Resiliency: Investing in Our Students, Our People, Our Future also strengthens the resiliency of Broward College through employee retention and development while streamlining core functions and optimizing revenue generating sources.

The budget, presented by John Dunnuck, senior vice president, Finance and Operations, includes an increase in State of Florida operating appropriations of \$2,740,121. The new spending plan is highlighted by a \$5.3 million investment in student resiliency. This includes a student experience redesign project that focuses on the delivery of services from start to finish; building capacity to support minority males and increase their retention, expanding outbound student outreach, virtual job shadowing, career readiness, and micro-credentialling and badging. Organizationally, the College also plans to increase diversity, equity, and inclusion training; improve internal culture through enhanced employee engagement, and support retention by setting aside \$4.7 million to recognize full-time employees who were instrumental in overcoming obstacles to keep students on a path toward success during the pandemic and have not received a salary increase since 2018.

Broward College Pays Homage to Trustee Chair Fernandez

President Haile extended heartfelt appreciation to Gloria Fernandez, who has served as a trustee since 2013 and chair of the Board since 2018, for her demonstrated passion for serving students and the community. During her tenure, the College improved its academic rankings and was named an Aspen Top Ten finalist four times—twice with distinction.

In presenting her with a proclamation, President Haile said Fernandez, who routinely leveraged her real estate expertise to support the College and its students and helped to foster a spirit of entrepreneurship through non-traditional revenue generation, has been a guiding force in the Willis Holcombe Center re-development project that will net the College \$200 million over the duration of the lease agreement. In recognition of her eight years of tireless service and leadership, the College named the Gloria Fernandez Conference Room in the main library on A. Hugh Adams Central Campus in her honor.

Congresswoman Discusses Available American Rescue Plan Funds

Congresswoman Debbie Wasserman Schultz (FL-23) met virtually with the Board of Trustees to discuss opportunities available for new and existing Broward College students that can help them pay for an array of education expenses because of the millions of dollars included in the American Rescue Plan legislation. Passed

this spring, the landmark relief legislation provides more than \$36 billion in funding to colleges, universities, and their students. Nearly half of that is targeted to students through emergency grants.

"There are millions of game-changing dollars available in our South Florida community, right now, for students to take advantage of—money that could be life-altering for so many families as we come out of this brutal pandemic," Wasserman Schultz said during the meeting. "Broward College is uniquely situated to help turn thousands of lives around because of that historic legislation. The key is getting that word out to students. For anyone struggling with tuition, food, housing, childcare, or wi-fi costs due to the pandemic, help is here, and it's waiting for you at Broward College."

College Honors City Furniture Owner

The Board of Trustees saluted Keith Koenig, CEO, and owner of City Furniture, for his help transforming students' lives and enriching the diverse Broward College community through academic excellence, innovation, and meaningful career opportunities that promote economic growth, well-being, and quality of life. In presenting a proclamation,

President Haile said, under Koenig's leadership, his company has partnered with the College to address the skills gap by increasing educational attainment leading to employment opportunities at City Furniture for Broward College students at no cost. The work also targets Broward UP residents in communities with high unemployment and low post-secondary attainment.

Policy Changes

At the June meeting, the Board approved changes to Policy 6Hx2-5.01, Admissions. The changes allow students to be considered for admissions from non-accredited high schools after review by the Registrar, and allows non-degree seeking students to take more credits.
