Broward College Ranks Among Top 20 Colleges and Universities in Graduating Hispanic Students



Broward College ranks as one of the top 20 colleges in the nation for conferring degrees on Hispanic students, according to a survey conducted by *Hispanic Outlook in Higher Education*. The findings are based on the 2012-13 academic year, when the College awarded 1,973 undergraduate degrees to Hispanic students, an increase of nearly 34 percent from the previous year, earning Broward College a ranking of 16 nationally.

During that same year, Hispanic females earned more than 1,000 degrees, while nearly 800 were awarded to Hispanic males. Broward College also ranked sixth in the nation for enrollment of undergraduate Hispanic students with 12,754, representing 34 percent of overall enrollment of students at Broward College.

"Broward College is honored to be recognized for our diverse student body and a growing number of Hispanic students attaining their degrees," said Broward College President J. David Armstrong, Jr. *Hispanic Outlook in Higher Education* is a magazine published bi-weekly that informs college students,



organizations and communitybased corporations of matters Hispanic students encounter on college campuses.

College Freezes Tuition for Third Consecutive Year

For the third consecutive year, Broward College's District Board of Trustees announced that the College will freeze tuition for in-state students during the 2014-15 academic year. The decision to hold tuition and fees aligns with the College's commitment to offer affordable education. With tuition at \$105.90 per credit hour for Florida residents for an associate's degree, Broward College offers the lowest higher education cost in South Florida and the second lowest in the entire state.

College Accreditation Officially Reaffirmed

On June 19, 2014, the Committee on Criteria and Reports of the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) voted to reaffirm the

accreditation of Broward College for another 10 years — through 2024. The reaffirmation comes with no recommendations or findings — a first in the College's history.

Regional accreditation is essential to recruit students, offer financial aid and create transfer opportunities to universities. It opens the door for the College to receive public and private grants and gives the general public a measure of confidence in the quality of the education Broward College provides. It also helps create and track continuous improvement requirements, the assessment of student learning outcomes and a Quality Enhancement Program (QEP) — in our case called "Question Every Possibility" — which targets our students' critical thinking skills.

Avis Proctor, Ed.D., was formally appointed president of Broward College's North Campus earlier this month. She has been serving as interim president since 2013. As the campus' chief executive officer, Proctor is primarily responsible for campus operations, including academics, student and business affairs, health sciences, learning resources, information technology and facilities.

"It is an honor to serve North Campus, and I am eager to continue my work with students, faculty, staff and the community to meet local needs, and contribute to the national discourse on student success at a community college," said Proctor.

Proctor joined Broward College in 2000 as a mathematics faculty member and subsequently served as associate dean of the North Campus mathematics department, before moving on to be the College's associate vice president for academic affairs. She has more than 20 years of experience as an educator and academic administrator. She received her doctoral degree from FIU, her master's degree from FAU and her bachelor's degree from Florida A&M University.

Rousseau, Downey Named to Supply-Chain Council's Board of Directors

Bradley, Elam Retire After Combined 70 Years of Service



Two Broward College employees retiring after 70 years of combined service to the college were recognized at the June board of trustees meeting. Linda Bradley, a Broward College employee for 36 years, came to the college as a clerk typist II in 1978 and leaves as executive assistant to the associate dean of enrollment services. During her time at the college she earned her A.S., A.A. and B.A.S. "Being at Broward College has been like a family to me," Bradley said. "My sons attended classes here in the summer when they came home from college." Some of her 11 grandchildren also attend Broward College.

Communications professor Jerry Elam devoted 34 years at Broward College, teaching and serving as an administrator on the North and Central campuses. In addition to teaching classes, Elam served as the campus advisor for North Campus' then-student newspaper, Polaris, and later, when the college changed to a single collegewide student newspaper, The Observer, he helped lead it to a pair of Pacemaker Awards, community college journalism's equivalent of the Pulitzer Prize. Elam also was the recipient of the 1993 A. Hugh Adams Endowed Teaching Chair. "Over half my life, I've worked at Broward College," Elam told the trustees. "The college has given a lot back to me. I don't know what I'd have done without it."
