The workshop will include both classroom discussion and interactive role playing exercises to achieve the course objectives.

- Identify critical factors that can impact their leadership roles
- List strategies for effectively coaching subordinates
- Explain strategies for effectively motivating subordinates
- Demonstrate strategies for effectively counseling subordinates
