# FAQ

- **Q:** What methods of placement are permitted aside from the Alternative Methods?
- A: Common placement testing and valid course equivalency for courses passed at another institution are still valid methods of placement.
- **Q:** What is the scoring scale for PSAT (8/9, 10, and NMSQT)?
- A: Like the SAT, the PSAT in all its versions is scored on a 10-point scale. The score range differs according to the version of the exam. An example of the scoring logic is as follows: 500, 510, 520, 530, 540...etc. No scores in between exist such as 525, 639, etc.

- **Q:** Who is included in this process?
- A: This process includes students who do not qualify for the developmental education exemption as defined in Florida State Rule <u>6A-10.0315</u> and Florida Statute <u>1008.30</u>.
- **Q:** What or who authorized the use of Alternative Methods for placement for Fall 2020?
- A: Per <u>Emergency Order (EO), DOE Order No. 2020-EO-02 (VIII e)</u>, FLDOE issues this emergency order on May 13, 2020. It permits institutions to develop alternative methods for placement to aid in the availability issues and hurdles for common placement testing during the COVID-19 pandemic.

The requirement in section 1007.263(1), F.S., to use a placement test to demonstrate achievement of college-level communication and computation skills is suspended through the fall semester of 2020. In addition to or in lieu of tests, college credit programs are permitted to use alternative methods selected by the college for placement into developmental education, where applicable.

Alternate methods were approved by Dr. Nasse and Dr. DeSanctis on June 4, 2020.

- Q: Will the Alternative Methods be used for placement into Spring 2021 (20212)?
- A: Not at this time.

## **Process for Utilizing Alternative Methods - Test Scores**

- First verify eligibility for use of test scores:
  - Does unweighted high school GPA match? (except GED 2014)
  - Does the 2 or 5 year score time limit match?
  - Are the score eligible?
- Test scores are to be entered into CID using Appendix B.
  - Scores will be entered by the testing centers. Staff are to send official and/or personally verified unofficial score reports/transcripts via email to your campus testing center email address for entry into CID. Be sure to send along the student ID in the email.
- Test Dates
  - Use the following date as the test date for each version of the PSAT. Actual test dates are not listed on PSAT score report. If need be, ask the student what grade they were in when the took the test and use that date for the entry in CID.
    - PSAT 8/9: April 30, XXXX
      - Happens in the fall of the student's 8<sup>th</sup> or 9<sup>th</sup> grade year.
    - PSAT 10: April 30, XXXX
      - Happens in the spring of the student's 10<sup>th</sup> grade year
    - PSAT/NMSQT: October 31, XXXX
      - Happens in the fall of the student's 10<sup>th</sup> or 11<sup>th</sup> grade year.
    - GED 2014 in English: Use the date on the score transcript.
  - Add the XX designator to the students record.

#### **Process for Utilizing Alternative Methods – Courses**

- First verify eligibility for use of test scores:
  - Does unweighted high school GPA match?
  - Does the 2 or 5 year course taken time limit match?
  - Are the grades eligible?
  - After verification is completed, follow these steps for placement in CID.
    - If unofficial high school transcripts are used, then:
      - Provide the appropriate course override necessary for registration into the math or English course.
      - Add the XX designator to the students record.
    - If **<u>official</u>** high school transcripts are received, then:
      - Provide 'Met through Permission' placement in SR TS SP SD in the appropriate areas:
        - Language add to both Reading and English
        - Math add to Math
        - Make sure the XX designator is found on the students record.




