GENERAL STATEMENT

The President shall establish procedures and provide information as necessary to ensure that all users of the Broward College ("College") website are aware of the policies regarding the gathering, retention and distribution of personal information when using electronic resources.

THE POLICY and THE STUDENT and THE FACULTY AND STAFF

The College will collect and retain personal information about users only to the extent necessary to provide the service or benefit desired; collect only appropriate information; provide the reason the information is collected so that users shall understand that reason clearly; enable users to examine their personal record which is maintained by the College; and inform users how to opt out of College communications and third-party network advertisers.

IMPLEMENTATION and OVERSIGHT

The information technology department shall maintain a web privacy statement accessible for public viewing on all pages of the official College website at http://www.broward.edu. The statement shall outline the use of personal information and how the College is strongly committed to protecting the privacy of the individual including the use of industry-leading technologies to ensure the security and confidentiality of such personal information http://www.broward.edu. The statement shall outline the use of personal information and how the College is strongly committed to protecting the privacy of the individual including the use of industry-leading technologies to ensure the security and confidentiality of such personal information.

The privacy statement shall address and include the following topics regarding the use of the College website by students, faculty, staff and the public:

- Definition of personally identifiable information.
- Methods for collecting and storing personal and anonymous information.
- Methods to opt out of communications and third-party ad network tracking.
- Dissemination of personal information.
- Third party usage and legal obligations.
- Safeguards that the College employs to protect confidentiality and security of personal information.
- The responsibility the College employs regarding links to websites outside of the College website.
- Notification of changes made to privacy practices.
- Privacy and security information about cookies, recommended encryption and browser types.
- Contact information for users who may have questions or need further clarification.
